A motion was made and seconded to contract with Clarke to do the application for \$15,097.50. Motion carried by unanimous vote.

Jeff will contact Clarke, more information will be coming on dates of application. Jeff will also contact Joe Pollardy, since DNR requires us to have professional help with pre and post application point intercept surveys. He gave us an estimate of approximately \$6000 for his help with this.
