2021 Surface Water Grant:

- 1) ProcellaCor application: After **much work** from Jeff, the application took place as planned. They finished in about 3 hours.
- 2) Point intercept of treated areas: All of the required testing is finished and has been sent off to the lab per DNRs request.
- 3) Late Summer Point intercept: no date has been set, volunteers would be appreciated.

- 4) Late summer EWM mapping: no date has been set, volunteers would be appreciated.
- 5) Summary of In-Kind contributions: All volunteer hours from Jan.1-July 31 need to be turned in so we can get our In-kind payment from DNR grant. Please email Jeff your hours.
- 6) Grant Management: We owe Clarke (ProcellaCor applicators) \$16,978, we have a lab bill for the DNR required water samples of \$5,022 and we will owe EOR for Joe's help with our point intercept on June 14.
- 7) 2022 Planning: we want to remind everyone that the Grant only 'pays' us after we have paid our bills. We are very grateful for those lake owners who have stepped forward with financial donations to our lake improvement fund. Those donations help us to pay our bills which we can then apply for reimbursement through the Grant. Your donations of volunteer time also qualify us for financial reimbursement through the Grant.
