In September, 2023, the DNR stocked 67 large fingerling muskies in our lake. These are usually about 9 to 13 inches in length. Please handle them with care while releasing them if you happen to catch one.

Change made to the phone services. Ended business with Frontier which was costing 300.00 per year. Now using I-Socket with a 200.00 initial hookup fee and a monthly fee of 4.98 vs 30.00. Total yearly fee for I-Socket is 59.00.

Rope used around open aerator water was a tangled mess when pulled from the water in Spring. It was approved for Joe to purchase 650' of new rope for this years project. 2024 aerator fence install will be Saturday, January 6, 2024. Volunteers are needed to help with the installation and attend the chili feed following. Let Joe Hubers know if you can help or having any questions.

In the past , fencing has been put up to keep snowmobiles from coming onto the lake through the aerator driveway used to set up the aerator. It will be discussed if we need to install again this year.

Joe and Mark have installed the heat tape in the pipe for the winter.

American Family dropped our insurance policy in September for the aerator shed, new insurance was purchased through Klinner Insurance.

An interesting year as we review our water quality testing data. We had a very late ice out this spring and this actually led to exceptional water clarity through most of June. We then expected to see significant weed growth due to this clarity. While we did enjoy this clear water, the usual algae induced loss of clarity was back by mid-August. Remember, Phosphorous is the primary nutrient in our lake. Limit fertilizer and be aware of runoff from your property. Minimize stirring up the bottom when boating in shallow water. These all-impact clarity but they also remix the nutrients back into the lake.

Your MLA has been formally reporting water quality data since before 1990. While we all tend to reflect on a snapshot in time, reviewing the data over time is important. The WDNR has created a new water quality reporting tool that shows all of our data over time. It might be worth a look. Linked here.

As we reported earlier, a group of MLA volunteers were on the lake on Sept 9 completing another Point Intercept study. We go to several hundred predefined GPS points, drag a rake, and catalog the aquatic plants we find there. The good news is, for the second summer we could find no EWM. We have battled this invader beginning in 2016. While we can enjoy our success, our attention to invasives impacting our lake is far from done. We must shift our efforts to prevention and ongoing regular monitoring. We need your help as many lakes around us now have invasive issues. Remind your guests of their responsibility. They will find new signage and tools at the landing. Please volunteer some of your time at the landing doing CBCW education for visitors. Training can now be done online making participation easier than ever.
